Frågan om In-house consultants

Under vårt möte kom en återkoppling på In-House consultants. Tidigare i detta ärende skrev vi till RES för att få klarhet i ämnet.

Svaret nedan förmedlades till projektet, men verkar nu ifrågasättas av PO (Project Officer):

- As indicated in the H2020 AGA, are considered as “in-house consultants”, **natural persons** working under a direct contract with the beneficiary other than an employment contract under the eligibility conditions set out Article 6.2.A.2 of the H2020 MGA. As clearly stated in the H2020 MGA and AGA, it only concerns cases of a direct contract between the beneficiary and a natural person and **does not cover the cases of staff provided by another entity against a price**, including staff provided by a temporary work agency.
- The approach is similar under Horizon Europe, except that the person must be hired either under a direct contract signed between the beneficiary and the natural person (not through another legal entity; e.g. a temporary work agency, as explained above for H2020) or under a contract signed between the beneficiary and a legal entity fully owned by that natural person, which has no other staff than the natural person being hired.
- If staff working on the action is provided by another entity, it may fall within one of the following categories:
 - Staff seconded by third parties providing in-kind contributions against a price, provided that it is not the economic activity of the beneficiary. In that case, the costs could be eligible as personnel costs under Article 6.2.A.3 H2020/HE MGA – and for H2020 provided that the conditions set out in Article 11 of the H2020 MGA are fulfilled.
 - Costs of subcontracting under Article 6.2.B H2020/HE MGA, if the third party (i.e. company providing the staff) carries out directly some task of the action - and for H2020 if the conditions set out in Article 13 of the H2020 MGA are fulfilled.
 - Costs of other goods and services under Article 6.2.D.3 H2020 MGA/Article 6.2.C.3 HE MGA, if the third party only provides staff to the beneficiary which is necessary for the action and if the conditions set out Article 10 of the H2020 MGA / Article 6.2.C HE MGA are fulfilled.

Blind evaluation

5. Evaluation and award:

Award criteria, scoring and thresholds are described in [Annex D](#) of the Work Programme General Annexes.

For the second stage, the thresholds for each criterion will be 4 (Excellence), 4 (Impact) and 3 (Implementation). The cumulative threshold will be 12.

Submission and evaluation processes are described in [Annex F](#) of the Work Programme General Annexes and the [Online Manual](#).

This topic is part of the [blind evaluation pilot](#), under which first stage proposals will be evaluated blindly.

 Blind evaluation pilot – If indicated in the specific call conditions, first-stage proposals of two-stage submissions will be evaluated blindly²⁶ and applicants may not disclose their identity in Part B of their proposal (see Annex A above).
